Standing Committee Reports:

Treasury: See attached report. Andrea shared open balance of \$26, 809.77, Income was \$3768.00. Donation of \$2500.00 from LA intergroup for our help with the Happy Birthday event. Expenses for month \$343.00. Ending balance \$30, 234.77. Reserves at M & T bank. Total Assets of \$36, 355.75. Ds Donations and insurance payments will go out in April and May.

Oasis: Mary Ann reported that Spring issue was published March 21 (Record 9 pages!!!!). Summer edition submittals due June 1st. **(Topic Big Book and Me)**. Will reach out to some people for articles in next couple of weeks. If you are running event, please share recap blurb to her.

Info Line/Telephone Committee: Brenda shared we have 4 calls this week. 2 were returned with conversations. Waiting for other 2 to return her call.

Public Information: Marcy is working with houses of worship to get flyers to them. Mark got flyers and pamphlet from storage and distributed to committee for them to share. Facebook ad was doing great (932 hits to website)! Facebook will not run ad anymore due to content regarding "weight loss". Toni Ann shared part of article from Facebook.
